

RMLL Regulation 32: Exhibition Games

Revised for RMLL 2021 Return-to-Play.

32.1. An Exhibition Game is any game/scrimmage between players from two different Franchises. A scrimmage/game between players from the same Franchise is not considered an Exhibition Game.

32.2. An Exhibition Game with a 16U Team is not a RMLL Exhibition Game. For this type of Exhibition Game refer to ALA Regulation 9. The Major Franchise must still however, submit the game sheet to the RMLL Executive Director and Division Commissioner.

32.3. In an Alumni Exhibition Game, all RMLL players playing must have completed the 2021 RMLL Intent-to-Play. As per ALA Regulation 6.14 Alumni players may register with the ALA Office via an Excel spreadsheet for a single Exhibition Game with no applicable fee to the ALA.

Regulations 32.4 to 32.7 Are Only Applicable from June 19 Through September 1, 2021

32.4. All Franchises intending to initiate or take part in Exhibition Game must first secure permission from their Division Commissioner.

32.5. A six (6) day minimum notice period is required.

32.6. Upon approval from the Commissioner(s), both Franchises playing in the Exhibition Game must enter the game details: Franchise playing, date, time, and location, in their Team Events Tab of the RMLL Team Management System.

32.7. The RMLL Executive Director will forward the automatic e-mail notification of the Exhibition Game Event and the Schedule Template to the RMLL RIC at least four (4) days prior to the game.

32.8. The current Season approved ALRA rates, assigning fee, travel rate and per diem, applies to all Referees officiating a RMLL Exhibition Game.

ALRA Exhibition Game Notes				
For both Standard and Non-Standard Game Durations the ALRA mileage & per diem apply, if applicable.				
When teams of differing Divisions play a Game where the duration is greater than 45 minutes, the LOWER of the two RMLL Division Game Fee Rate will be paid. Examples:				
	1) A Tier I team plays a Tier II team; each official will be paid \$73 per game;			
	2) A Sr B team playing a Sr C team will have both officials paid \$79 per game;			
	3) A Midget team playing a Tier I team have both officials paid \$79 per game, as the Tier I team is the lowest RMLL participant.			
For teams from the same or different Divisions playing a game with a scheduled playing duration under 46 minutes, the game fee rate will be \$65 for both officials.				
For teams who play multiple Exhibition games in a day, with teams from differing Divisions playing in games with a scheduled playing duration greater than 45 minutes, all games will be paid at the same rate, determined by the Division of the teams that make up the majority of participating teams in the multiple Exhibition games, rounding up if there is a tie. Examples:				
	1) Three Tier II teams and a Tier I team participating; all officials will be paid at \$73 per game;			
	2) Two Jr A teams and two Tier I teams participating; all officials will be paid at \$85 per game.			
For teams who play multiple Exhibition games in a day with teams from the same or different Divisions playing games with a scheduled playing duration under 46 minutes, all officials will be paid at \$65 per game.				

32.9. The Franchise initiating the Exhibition Game is responsible for the payment of the game fees to the Referees. The Referees are to be paid prior to the start of the game.

32.9.1. The ALRA assigning fee, travel rate and per diem will be split between the Franchises participating in the Exhibition Game and will be invoiced to the two Franchises at the end of season play.

32.10. The Game Sheet for an Exhibition Game must be submitted to the RMLL Executive Director and the Division Commissioner of the Franchise initiating the Exhibition Game. If the two Franchises participating in the Exhibition Game are from two separate Divisions, then the Game Sheet must be sent to both Division Commissioners.

32.11. A player playing in an Exhibition Game must have completed the RMLL Intent-To-Play.

32.12. No player may participate in any Exhibition Game unless the player is eligible for that team, except that:

32.12.1. The player is a member of another Franchise (on 2019 roster and 2021 eligible) or has obligations (by agreement or Regulation) to the Franchise for which the player was last signed, and the player has written permission from that Franchise for Exhibition Games played after May 1.

32.12.2. An out-of-Province player without a completed CLA transfer must have written permission from the last team owning his playing rights.

32.13. A player, goalkeeper, or non-playing personnel with carryover suspension(s) from previous seasons (e.g., 2019) must serve the suspension in 2022 RMLL League Play.

32.14. For the 2021 Return-To-Play, a player, goalkeeper, or non-playing personnel who receives a suspension, will serve the suspension in Return-To-Play play. The suspension must be served with the Team whose game day roster they were on when the infraction occurred. Until the suspension is served, the player, goalkeeper, or non-playing personnel cannot be on the game day roster of another team in the role they received the suspension for. Any suspension that continues beyond the 2021 Return-To-Play will be served in 2022 RMLL League Play.

32.14. Exhibition Game Day Rosters cannot exceed 22 (twenty-two) runners and 3 (three) goalies.

32.15 The amendments made to this Regulation 32 on June 8, 2021, by the Executive of the RMLL shall only be effective until Midnight September 1, 2021, at which time they will automatically expire and be of no force or effect and revert to the form of Regulation 32 which existed on June 7, 2021.
