

2024 Jr. B Tier 1 Planning Meeting Minutes November 25, 2023 Delta Hotels by Marriott Edmonton South Hotel & Conference Centre

- 1. Meeting was called to order by Ian Stewart at 9:15am
- 2. Additions to the Agenda

- Approval of 2024 Planning Meeting Agenda
 Motion to accept agenda made by Terry D., second by Jason, all in favor.
- Approval of 2023 Planning Meeting Minutes
 Motion to accept minutes made by Brad, second by Jason, all in favor.
- Tier Change Request Cranbrook Blackwolves
 Presentation by Russ Shepard All details were made available prior to the meeting. Russ summarized points of emphasis for bid.

Discussion:

- They were competitive in their exhibition games with the Barracudas and Shamrocks.
- Were unable to successfully develop referees as per league ask in 2023.
- Concerns regarding travel costs for current teams & having to raise teams fees for current teams.
- Would consider a one (1) year trial to allow for more planning as a division.

8. 2024 Team Fees

- Registration Fee for ALA will not go up for the upcoming season. This
 applies to the player fees when signing up in RAMP for their Intent to
 Play.
- Proposal at AGM on Sunday to increase RMLL team fees from \$800 to \$950.

9. ALRA 3-Man Mechanic Discussion

- 3-Man Mechanic is being adopted in all Provinces and by Lacrosse Canada for the National Championships. A strong desire by the ALRA to continue with this onwards.
- Teams feel that there was no benefit to continue with this as there was no development of other refs and it drove up game day costs.
- It was decided that an email would be sent to the teams asking for them to list the good and bad that they experienced last year with the 3-man referee system and what the expectations were of our clubs. The information will be collected and sent to the ALRA.

10. Surveys for Alberta teams

- Disappointment by the lack of response from the Jr A teams.
- Are there different issues in the North than in the South? Central Alberta teams have little to no communication with either.
- Jr A clubs are treating their 50 Man Protected List as their roster.
- Fear that messaging to the players is to miss Tier 1 games or practices.
- Players are being called up to travel to away games and then not playing

Motion to ask RMLL Executive to change the Jr A Protected List from 50 down to 35 made by Vay, second by Dave. All in Favor.
