#### Business arising from the 2025 RMFL Exec meeting.

- ALRA game referee fees for all division are now \$90 per referee per game

- RMILL Franchise fees. No increase. Currently \$1250 (\$950 RMILL, \$200 contingency fund, \$100 NAIG)
- RAMP/ALA fees. \$87 per player, \$57 per coach, \$47 per trainer
- Provincial ALA fees. Teams participating in provincials the fee is \$1500 same as last season
- RMILL 2024/25 financials. Income was over budget. Expenses were under budget. RMILL financials are healthy.
- ALA Regulation effecting major. Regulation 5A.01 has been revised
  - **Affiliations of players on a Team Alberta roster to Major Female Lacrosse are not permitted after the player's minor Lacrosse season has ended.**
- Casino. No casino this year
- Super clinic. The 2026 RMILL Super Coaching Clinic will be held in Okotoks Rec Centre on April 10, 11, & 12
- Coaching. Due to no longer having to complete and submit a workbook, coaching goes from 4 years to 3 years for a coach to be Comp Intro Certified. All coaches need to complete the Safe Sport Module.
- RAMP changes. Players male and female will now be required to enter 'gender identification' when registering in RAMP. RAMP registration should be open December 1<sup>st</sup>, 2025.
- Games sheets/ Ref reports.
 

ALA and RMILL have moved to electronic/online game sheets for the 2026 season. Upgrades to Sportzsoft are being made.

Do not have to scan and send in game sheets. You can still use paper game sheets but all stats are entered online through the app.

Ref reports are also moving to an online app. The app should be ready for the 2026 season.

Warriors new team application.

- Darryl Mackinnon, head coach and Mike Baker Warriors president presented the Warriors new team application. Discussions and questions followed. After the Warriors reps left, discussions continued for almost three hours looking into different ways to accept the new team. But in the end the division denied the application. The biggest concern was availability of players to support ALL teams in

the North. Additional concerns; arena availability at Meadows, there are two other teams that need players and are welcome to play for. No female coach on application and player sustainability long term.

### Referees

- David and Jack from the ALRA joined our meeting to discuss things that went well and things that did not and the plans moving forward for the 2026 season. David apologized to the division, the ALRA messed up game assignments. They did not realize how talented female lacrosse has become and under qualified refs were used too many times. But changes have been made to fix that. Over all it was a very positive meeting.  
Our division will not see the 3 man mechanic in regular season games, only for provincials.

### Business arising from the 2025 season

- Additional player awards. We will continue with the current most goals and most points awards and plaque. For additional end of season awards coaches/teams will select an 'all star' team to post to the website.  
**TASK:** Alex to set up the 'all star' team selection process and distribute to the division for review and discussion.
- North boundaries. After discussion boundaries will remain as set.
- RMLL Regulations:  
**31.10.1.1** Review with division 25 players for provincials. After discussion the teams would like to go back to a 30 player roster for provincials.  
**TASK:** Alex to bring to the RMLL exec for discussion. At the RMLL exec meeting on Sunday Nov. 16<sup>th</sup> Alex presented the desire to go back to a 30 player provincial roster and the request was turned down.
- June 15<sup>th</sup> roster freeze. After first season with the June 15<sup>th</sup> roster freeze, no issues.
- North hold out list. Approved Review schedule 11 in regs
- U17 info sessions. No in person info sessions.  
**TASK:** Alex will send out welcome letters for junior and senior teams to review and send out to graduating classes.
