 - b. **Division asked Terry for more details around the Winnipeg minor system as well as the Jr. B Tier 1 program so that they could have a better view of the long term viability of the Winnipeg team in the Jr. A division.**
 - c. **Further discussion was around amending the LC rules around interprovincial transfers within the Jr. A league given it's a multi province league. I believe AJ is going to look into this?**
5. Scheduling
 - a. **Blackout Dates only day given was the August long weekend.**
 - b. **Ex Game Weekend & Schedule (Ex games to be held in May. Dates to come)**
 - i. **Mounties want to go to BC, Medicine Hat and Red Deer**
 - ii. **Raiders want to go to Red Deer and Medicine Hat**
 - iii. **Miners want to go to Red Deer, BC and Saskatchewan (Lloydminster)**
 - iv. **SWAT want to go to Medicine Hat and Saskatchewan (Lloydminster)**
 - c. **Regular Season – Sunday Start Time & SK Victoria Day Weekend Rotation**
 - i. **If possible, the division would like 1:00 start times for teams that have to travel long distances.**
