Motion that tier 2 adopt Jr A affiliation rules from tier 1 plus add their protected lists to 50. 10. New Team(s) Applications - Peace Country (Grande Prairie) and Medicine Hat

Fort St John and GP to draw players. Graduated 20+ kids in the last couple seasons. Couple drafted but have not played higher. 20 letters of intent signed for players. Expected sustainability of over 5 years. \$100,000 - \$120,000 first year budget. Have lots of sponsors ready to donate. Dissolved in 2016. Players billeted from Fort St John in GP. Fort St John has had no u15 or u17 programs as they're rebuilding. Big challenge developing refs. Have roughly 10 kids interested in reffing. One team at every age level in minor lacrosse, just over 100 kids last year. Program is growing.

Axemen motion for peace country, second Charmaine D.. The condition of having 3 home weekends per year for the first 3 years of the franchise then revisited in 2029 planning meeting. Approved.

Medicine hat application looking to start up again, had jr b tier 2 for years. Coaching is promising for the foreseeable future. Numbers in SALA are starting to pick up again to pre covid numbers. U17 had a strong division. A lot of kids in Medicine hat are not playing major lacrosse. One upcoming season with low U15 numbers. Badlands lacrosse club just medicine hat rebranded. 5 Kids on chaos will have a choice if they wish to stay with the Chaos or go to the Badlands team. Part of application was to get Brooks back – Talked to Christine and this would have to be a boundary discussion if Badlands was accepted. Still have money in the bank from Sun Devils days. Focus on getting kids back into the game. 24 Kids have expressed interest in playing. Kind of got the indication that players from chaos have been spoken to. Players in boundaries will get a one-time option to stay or go to Medicine Hat. Long term sustainability hoping to get 4 years out of U17 players. Just asking for medicine hat for boundaries today. 4 Potential officials

Medicine Hat can join the league under the condition with the southern Alberta chaos boundaries will remain the same. Axemen motion second Mike Clark – Approved.
